Rattlesnakes can cause serious injury to humans - on rare occasions even death, as was evidenced in May when a rattlesnake bite killed a Riverside County man. While generally not aggressive, rattlesnakes strike when threatened or deliberately provoked, but given room they will retreat. Most snake bites occur when a rattlesnake is handled or accidentally touched by someone walking or climbing.

Although scary, the California Poison Control Center notes that rattlesnakes account for only about 800 bites each year with about one to two deaths. The Here in Sunland-Tujunga the rattlesnake species we

can expect to find include the Western Diamondback, Sidewinder, Speckled rattlesnake, Red Diamond rattlesnake, Southern Pacific, Great Basin rattlesnake and the Mojave rattlesnake. Just use common sense! The possibility of finding a rattlesnake shouldn't stop anyone from venturing outdoors, but there are several precautions that can be taken to lessen the chance of be-

ing bitten when out in snake country - which is just about anywhere in California.

5) The homelessness and security dilemmas are being treated as cottage industries, and that is NOTHING to be proud of—and the wasting of an opportunity to grow an economy based on jobs, low crime, and low urban blight won't fly anymore as we confront the 2028 Olympics and a city/county of Los Angeles that needs to put the pandemic behind us.

6) Whether it's Yaroslavsky or Horvath or any city/county leader, we have no business re-electing them if there are others waiting in the wings to replace them. We're about ready to throw out District Attorney Gascón as Step #1 to fixing rampant crime in L.A. County, and if L.A. City Mayor Bass wants to embrace our city as a homeless magnet, then she deserves replacing, too.

7) We've been building a countywide rail system for well over a decade with the 2028 Olympics in mind, but if it's earned a well-deserved reputation for being unsafe and a crime/homeless magnet, then that's just throwing the taxpayers' money right in their collective face (ditto for homeless taxes meant to fix, not extend, the problem).

In short, we've been giving the residents and taxpayers of L.A. City and County a raw deal for years, and forcing those we need the most to flee to other counties and venues. 

The Station Fire's 15th Anniversary

ext week, August 21, 2024, marks the 15th Anniversary of the Los Angeles Station Fire, the largest and deadliest fire recorded in the history of Angeles National Forest and the tenth largest fire in California since 1933. Many will recall the immense thundercloud that emerged over the local mountains.

The Station Fire was started by workers tending an illegal marijuana grow in the Angeles National Forest and was named for its proximity to the U.S. Forest Service Ranger station on the Angeles Crest Highway -2. The fire threatened the local communities of La Canada-Flintridge, Glendale, Acton, La Crescenta, Littlerock, Altadena, Pasadena, Sierra Madre, Sunland and Tujunga.

Lasting nearly two months, the Station Fire was finally at 100% containment on October 16, 2009. The task required more than 4,847 firefighters, 13 helicopters, 11 air tankers, 399 engines, 44 hand crews, 48 bulldozers and 43 water tenders to contain the fire; the cost was \$95,300,000. The fire burned a total of 160,577 acres and destroyed 209 structures—89 of them being homes—and took the lives of two Los Angeles County Firefighters.

More bodies were found months after the fire was extinguished. California firefighters and "Hot Shot" crews from as far away as Washington were able to save the burning slopes of Mount Wilson from complete involvement as well as save the threatened television, radio, cellular telephone antennas and the Mount Wilson Observatory,



the latter which includes several historically significant telescopes and multi-million dollar astronomical facilities that are operated by UCLA, USC, UC Berkley and Georgia State University.

The fierce fire left the Angeles Crest Highway (IS 2) destroyed, left 40 miles of barely passable lanes on Route 2, melted road signs, burned guardrails off their wood moorings, scorched tree limbs, and left debris and large boulders covering the road. To date, the U.S Forest Service has re-planted more than 4,000 acres and 23,000 trees a year on the 75 acres along the major roads to recover the 11,000 acres which were burned too deep in the soil and too wide-spread for nat-

ural seed regeneration. The California Department of Transportation has spent \$16.5 million to repair the Angeles Crest Highway, which reopened in June 2010.

More than 300 volunteers working thousands of hours succeeded in re-opening Deukmejian Wilderness Park after being closed for a little over a year. The hillsides were singed and the winter storms eroded parts of the park and filled the park with mud and debris.

The fire destroyed 709 park acres. Fire fighters were able to save the historic oak tree in the lower portion of the park. Two Los Angeles County firefighters: Captain Tedmund Hall, and Specialist Arnaldo Quinones, who were searching for an escape route from prison Camp 16, which supervised inmates, were killed during the fire when their vehicle went over the side of the road near Mt. Gleason. Circumstances suggest that Hall and Quinone were repositioning their truck on a small path near the prison camp when

they plunged 800 feet over the side of the road into the canyon.

During the height of the Station Fire blaze, 6,6000 homes were under mandatory evacuation and 12,500 homes were threatened. Eightynine residences were destroyed in Acton, La Paloma and the Vogel Flats in Big Tujunga Canyon.

The Forest Service began implementing the training and retrofitting of helicopters to use at night to fight wildfires in Southern California, a practice that was not in affect during the 2009 Station Fire.

Please be fire safe and prepare for evacuation if need be. A really bad fire season is coming and you need to be prepared.





Dear Rusty: I've been told that members of Congress do not have Social Security deducted from their pay; Additionally, that their retirement dollars come from the Social Security Administration purse even if they only serve as a member of Congress for a short number of terms. Also, if this is true, are there other individuals that enjoy these advantages?


Dear Concerned Senior: I'm afraid this is one of those "urban legend" kind of rumors that just seems to keep popping up, especially when the issues surrounding Social Security's financial prob-

Does Congress Pay Into Social Security?

lems come up. In addition to being untrue, it often is used to display the public's animosity toward elected officials and the feeling that Congress—and other elected officials—are above the fray, so to speak, and therefore not affected by the implications of Social Security's looming insolvency problem.

Here's the reality. Since January 1, 1984, all members of Congress, the President and Vice President, Federal judges, and most political appointees, are covered under the Social Security program. The rumor that these elected officials do not pay Social Security tax most likely is attributable to the fact that from 1920 to 1983, they were participants in the Civil Service Retirement System - CSRS - the federal retirement plan federal workers used even before the Social Security Act was passed. CSRS provided a pension for federal employees, so they were exempted from contributing to or collecting from the new Social Security program.

In 1987, then, the federal government officially changed over to FERS - the Federal Employee Retirement System – and all employes hired from that point forward are



covered under FERS. There are multiple parts to FERS, and one of them is mandatory FICA contributions. So, all federal employees—including members of Congress—are subject to the 6.2% FICA tax, are eligible for Social Security retirement benefits, and are governed by the multitude of rules and regulations associated with Social Security. But other than standard SS benefits which they may normally be entitled, no Social Security funds are used to supplement Congressional retirement.

In other words, the rumor that Congress didn't pay into Social Security was actually true prior to 1984, but today it is a misstatement of fact. And the federal employee retirement plans (both the prior CSRS plan and the current FERS plan) are totally independent of Social Security and do not negatively affect program solvency.


The Do's And Don'ts When Walking or Hiking

When hiking, stick to well-used trails and wear over-the-ankle boots and loose-fitting long pants. Do not step or put your hands where you cannot see, and avoid wandering around in the dark. Step ON logs and rocks, never over them, and be especially careful when climbing rocks or gathering firewood. Always avoid walking through dense brush or willow thickets.

Be careful when stepping over the doorstep as well. Snakes like to crawl along the edge of buildings where they are protected on one

Is It A Rattlesnake Or Isn't It?

Many a useful and non-threatening snake has suffered a quick death from a frantic human who has mistakenly identified a gopher snake, racer or other as a rattlesnake. This usually happens when a snake assumes an instinctual defensive position used to bluff adversaries. A gopher snake has the added unfortunate trait of imitating a rattlesnake by flattening its head and body, vibrating its tail, hissing and actually striking if approached too closely.■
